The Plantation Tennis Club – Terms and Conditions of Membership

These Terms and Conditions apply to all members ("Members") of *The Plantation Tennis Club* ("the Club"), operated by the **Royal Life Saving Society Queensland Inc** ("RLSSQ"), located at 1204 New Cleveland Road, Gumdale QLD 4154.

1. Membership

- 1.1 Membership is available to individuals who pay the annual membership fee of \$55 (inc. GST). Membership is not for persons conducting a business or those who are accepting fees for tennis related activity such as coaching.
- 1.2 Membership is valid for 12 months from the date of purchase and is non-transferable and non-refundable.
- 1.3 Members must be at least 16 years of age or have parental/guardian consent.
- 1.4 Membership subject to approval of RLSSQ, who may decline membership at its entire discretion
- 1.5 Reasons for declining or terminating membership include (but are not limited to):
 - a) In the complete discretion of RLSSQ the person or their behaviour is not suitable.
 - b) The person has an unpaid debt to RLSSQ,
 - c) The person has a conflict of interest with another tennis club or organisation,
 - d) the person (or persons accompanying them) damage assets or equipment, or undertake a prohibited activity, or cause unreasonable risk to RLSSQ.
- 1.6 RLSSQ may terminate a member's membership for any reason. There is no right of appeal for termination of membership.

2. Benefits

- 2.1 Members are entitled to a discount on tennis court hire fees when **booking online** at least **24 hours in advance**. The discount amount will be determined from time to time and may be changed at any time.
- 2.2 Discounts apply only to bookings made by the Member under their registered account.
- 2.3 RLSSQ reserves the right to change, suspend, or withdraw any benefits at any time without prior notice.

3. Court Hire

- 3.1 Standard court hire is \$20 per hour or such other fee as determined by RLSSQ.
- 3.2 All bookings must be made and paid online before play commences.
- 3.3 Members and guests must follow all facility rules and staff directions while on site.
- 3.4 RLSSQ does not guarantee access to courts even if a confirmed booking is made. Court access is subject to weather, availability of staff and other factors that can change at any moment.
- 3.5 Day and time of court availability changes through the year.

4. Administration and Governance

- 4.1 The Club is **operated and administered solely by RLSSQ staff**.
- 4.2 Membership does not entitle any person to voting rights, governance roles, or participation in management decisions.
- 4.3 RLSSQ may choose, at its discretion, to formalise or restructure the Club, which may include establishing a committee or alternative governance arrangements, or incorporating the Club.

5. Liability

- 5.1 Members use the facilities at their own risk.
- 5.2 To the maximum extent permitted by law, RLSSQ, its staff, and volunteers accept no liability for any injury, loss, or damage arising from participation in Club activities or use of facilities, whether caused by negligence or otherwise.
- 5.3 Members are responsible for ensuring they are medically and physically fit to play tennis or participate in activities.

6. Termination and Changes

- 6.1 RLSSQ reserves the right to terminate any membership or cease the Club at any time, for any reason.
- 6.2 If the Club is discontinued, no refund or compensation will be payable for unused membership periods.

RLSSQ may amend these Terms and Conditions at any time. The latest version will be available upon request.
